Important Notice

The swim team league program is designed to further develop existing swim strokes and build the strength and confidence of your child. However, swim team development is not considered to be *swimming lessons*. Coaches will evaluate new swimmers for a two-week period beginning **May 9** and ending **May 20**. If at the end of that period, if the coaches feel they cannot provide the attention needed to develop your child's existing skills, a board member and coach will meet with you to discuss other options that may be in your child's best interest. If the coaches or you feel that swim team may not be the best choice for your child during the initial two-week period on the swim team, you will receive a 100% reimbursement of swim team dues. (*Please note that this only applies to swim team dues and NOT to pool membership fees*).

Fees

Early Bird Registration - Prior to May 6th

Swim Team Fees: \$60 - First swimmer; \$50-each additional swimmer

AFTER May 6th

Swim Team Fees: \$65 - First swimmer; \$55-each additional swimmer

Membership at Jones Creek pool is required to participate with the swim team, except for Jones Creek residents. Jones Creek residents may join the swim team and not Jones Creek pool for an additional \$50.00 fee per swimmer payable to Jones Creek Pool. You must be a paid member of the Jones Creek Pool for 2011 prior to registering for Swim Team.

Membership fees are non-refundable after May 20th. **Checks should be made payable to Jones Creek Swim Team.**

Swim Meet Information

Meets are held on Tuesday nights. In case of severe weather, the make-up day for all Tuesday meets is Thursday. Meets begin with home team warm-ups at 5:00 pm. For home meets, swimmers should be at the pool by 4:45 p.m. For away meets, swimmers must be at the specified pool by 5:00 pm. The events start at 6:00 and last approximately 3 to 4 hours. Younger swimmers usually finish earlier. **Maps** to away meets will be provided at practice or can be found at www.csrswim.org.

Meets run quickly so that they are not too lengthy. Swimmers must keep track of the events and lanes where they are to swim in the meet. Event and lane assignments will be emailed to the parents by Monday evening. **Parents must ensure that their child are aware of their events and report to their assigned lane at least two events prior to their event**). Also, be aware that your child may be scheduled in a relay event toward the end of the meet. Please do not leave the site until you have checked with a coach to be sure that your child has competed in all necessary events. Swimming is a team sport, and relay events provide valuable points for the team! Sometimes, participation in relay events cannot be determined until the evening of the meet, so please check with one of the coaches before leaving.

Regardless of the weather, all swimmers MUST be at the site of the meet at the scheduled time, unless you have been notified via phone by a coach or board member. Please check your e-mail before leaving for the pool. You may also contact any board member.

Melissa Eustice Memorial Invitational Meet

The Melissa Meet (formerly known as the "B" meet) is held each year for the beginning swimmer (age 10 & under only) who is DEVELOPING their confidence and swimming strokes. This meet is for the swimmer who may not yet have a legal stroke technique, but may be developing that skill. The meet is all about FUN and RECOGNITION for those swimmers who may need some encouragement to boost their interest in swimming and to improve their skills. The Melissa Meet is specifically for swimmers who are 10 years and under and have not placed 1st - 3rd in any meet. In addition, swimmers who consistently place 4th through 6th are encouraged not to compete. This year, the Melissa Meet will be held on Saturday, **June 11th** at Petersburg Racquet Club.

Absences

In the event that a swimmer has a conflict with the morning practice schedule, make-up practices may be scheduled in the afternoon through the coaching staff. Conflicts include summer school, camps, vacation bible study, family commitments, doctor's appointments, etc. Make-up practices are limited to 15 swimmers, and they must be scheduled IN ADVANCE by contacting Head Coach St. Louis or Assistant Head Coach Huggins. Parents that know of a conflict should contact the coaches in writing or by e-mail as early as possible.

Efficiently scheduling the swimmers for each meet is the role of the Head Coach. It is important that the coach know who will not be at a meet ASAP. Any swimmer unable to attend a meet must notify the Head Coach St. Louis, in writing or by e-mail **no later than 5 p.m. the Friday before the meet.** Please email the Head Coach directly.

Team Swim Suits

Swimsuits may be purchased from Augusta Swim Supply, Inc., 265 Boy Scout Road, 738-0072, located on the corner of Boy Scout Road and Skinner Mill Roads. They will be able to show you the Jones Creek suit. For the 2011 season the Jones Creek Sharks swim team will require new swimsuits for the summer season. The official Jones Creek swimsuit and swim cap are required to participate in swim meets.

Team and Individual Photos

Team and individual photos will be taken before the time trials meet on May 21st. Please arrive by 7:30 **am**, and make sure your swimmer is wearing the team swimsuit. Sign up forms will be available at the pool.

Parent Volunteer Assignments

The Swim Team program can only be successful with the support of parents. There are many volunteers needed for every meet. **To adequately staff each meet, one parent from each family will be required to volunteer for a minimum of one-half of each meet in which your child is a participant.** We are required to staff every meet with volunteers, whether it is at home or away.

Parent volunteers serve in the following positions at every meet:

- **Referee** – (Certification Required): This is the Head Official. The referee may disqualify a swimmer for any violation he personally observes. He/she may overrule any meet official on a point of rule interpretation, make all final decisions, and ensure efficient running of the meet. The home team provides this individual. Training available via the CSRA Swim League – Dates TBD
- **Starter** – (Certification Required): This individual is skilled in starting events. He or she assumes control of swimmers from the referee and directs them to step on the block, "take your mark," and starts the event with a buzzer. The starter is responsible for stopping an event in which a false start has occurred. Training available via the CSRA Swim League – Dates TBD
- **Stroke and Turn Judge** - (Certification Required): Ensures that swimmers are doing strokes correctly. Training available via the CSRA Swim League – Dates TBD
- **Head Timer** – Experienced timer who starts stopwatches for each event, to back up lane times in the event of a watch failure
- **Timer** – Uses a stop watch to time events. This is an easy volunteer position, no experience required.
- **Runner** – Picks up timing slips and delivers to scoring table
- **Meet Manager Operator** – Run Meet Manager software, (requires a CSRA certification class).
- **Scoring table** – Help with timing slips, calling out times and verifying data.
- **Concessions** – Helps with set up, concessions sales, and clean-up.

Volunteer sign-up sheets will be posted on the bulletin board at the pool at the beginning of the season. All sheets must be filled out by May 20th. Any family who has not signed up for a shift will be assigned a shift based upon their preferences indicated on the Volunteer Form completed at registration. If a meet sheet is already full, you must sign up as an alternate. Alternates will be used whenever and wherever they are needed.

In the event a meet is rescheduled due to a rainout, a volunteer's position will be transferred to the rescheduled date. If your child will not be attending the rescheduled meet, please contact a substitute to fill your position and notify the coordinators by e-mail.

Reminder volunteer schedules will be emailed on the Wednesday prior to each swim meet. If you are scheduled to work and cannot fulfill the job, you must find a substitute and email the swim team at jonescreeksharks@yahoo.com.

Jones Creek Sharks Code of Conduct 2011

1. Parents and spectators should understand that the goal of summer swim league is to enhance childhood growth and development. Learning the fundamentals of swimming will be emphasized with additional focus on sportsmanship, teamwork and strokes.
2. Children learn what they observe. Your behavior sets the example. Inappropriate language and behavior will not be tolerated and may result in expulsion from practices and meets.
3. Parents and spectators should remember that they are there to support the children and not to draw attention to themselves.
4. Parents and spectators should understand that the coaches and officials are qualified in swimming and are trying to help the swimmers. Complaints and unsolicited advice are not welcome. Concerns and constructive criticism may be presented to the swim team president or CSRA representative
