

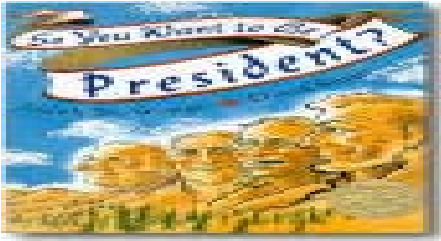

PRESIDENT'S MESSAGE



Well, we have finally made it to the Fall season after we had one of the hottest and driest Septembers on record in the Central Savannah River Area. However, tropical storm Tammy took care of the short-lived drought with over 4.5" of rain falling on Jones Creek over a very short period of time. We are going to attempt to get a community watch program active for Jones Creek. PRESIDENT'S MESSAGE

With the dramatic increase in landscaping costs being the major driver and the desire by the JCOA Board to have sufficient funds available to perform improvements (i.e., landscaping, fence repair, debris removal, etc.) to our common areas, the JCOA Board has approved an increase in the annual dues to **\$250 per year**. For more information on this subject, see Jim's article elsewhere in this newsletter. We will once again use a tiered payment schedule, with base dues starting at the new level, to assure that payments are completed in a timely fashion.

If any of our residents are interested in joining the Jones Creek Golf Club, now is the time to do so. The course is in great shape and the dues are the lowest they have been in several years. I encourage you to support your golf course because it inherently increases the value of your property, as the reputation of the course in the area gets better and better. 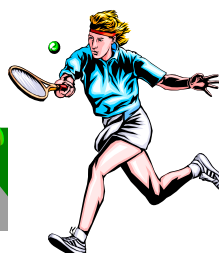

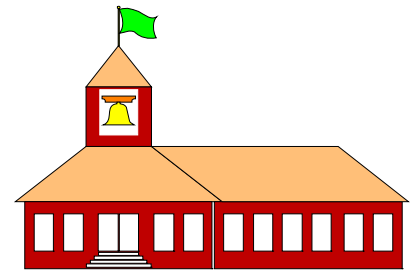

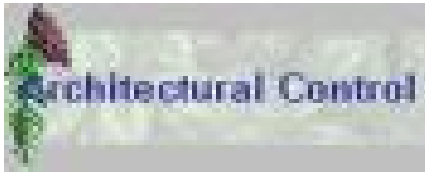

A Note from the Architectural Control Committee (ACC)

Keep Up Appearances: Gutters and Caulking

Protect your investment this fall with a little maintenance and you may save a few natural gas and electricity expenses.

Recently, I visited a Jones Creek property to approve the installation of a satellite dish. It was sort of amusing because as I approached the house, I noticed that the gutters were full of leaves and pine straw. In fact, there was actually a 14-inch tall pine seedling growing in the gutter and enjoying the view from the second story of the house. It was probably more like a planter than a rain catcher. I know the owner is anticipating a fall full of football games available on the sports menu but neglecting to maintain his property will hit him in the wallet.

Fall brings with it crisp days, and a little maintenance now can save time and aggravation in the months and years to come. Now is the time to check out your exterior to see if your gutters need harvesting. Inspect your roof line to check for gaps in the flashing, loose shingles, caulking failure, and mortar damage. These problems are definitely classified as, "pay me now or pay me more later", type.

If you have any of these problems you are definitely losing heating and air conditioning dollars.

In Jones Creek we have restrictive covenants requiring each owner to maintain and keep their lot and dwelling in good repair, condition and order, including, mowing and edging of yards. No owner or occupant shall make any exterior change, alteration, or construction, including painting, re-roofing, and landscaping, without first obtaining the written approval of the Jones Creek Owners Association (JCOA) Architectural Control Committee (ACC). Our most frequent violation is the removal of trees. The modification request form may be obtained from the Jones Creek web site or you may contact me at jcoaacc@comcast.net.

WHAT'S A C'RATA?

Even though we just have two tennis courts, 46 adult Jones Creek residents play on tennis teams in local league matches. USTA League Tennis is the world's largest recreational tennis league providing organized, structured team matches for all ability levels.

Approximately 500,000 players compete nationwide, with over 124,000 adult and senior players coming from the USTA Southern Section alone. The program is open to adults and features a local, state

and sectional championship and culminates in a [national championship](#) in each skill level.

Jones Creek is in a tennis organization area called the Central Savannah River Area Tennis Association, known as CSRATA, (i.e., c'rata). The tennis population is very large, for the organization's purposes, the geographic area is defined to include the counties of Columbia, Burke, Lincoln, McDuffie, and Richmond in Georgia, and the counties of Aiken, Barnwell, and Edgefield in South Carolina. There are three tennis seasons: spring, summer, and fall. The calendar runs from January to December. There are a total of 852 men and women registered CSRATA players in the fall of 2005; a little down from the fall of 2004, with 956 tennis players. Some of the players are counted twice or more because they play on two or more teams, at different NTPR levels, in any given season. The fall season is now half way completed. Registration for the spring 2006 tennis leagues will begin **December 2005**.

The purpose of CSRATA is to promote the development of the sport of tennis as a means of healthful recreation and physical fitness for all residents of the

area, and to cooperate with the USTA and other associations in the pursuit of these aims.

Guidelines for USTA Team Tennis, allow players to be part of a team, to play tennis for health and fitness benefits, and to learn to play tennis with others of similar skill and interest in a very organized format. Unlike having a golf handicap, tennis players do not carry a number indicating their playing ability, but they are rated on a skill level (i.e., NTRP levels 2.5 - 5.0) on the National Tennis Rating Program, called the Dynamic NTRP. Ratings are calculated weekly by a computer system called TennisLink available on the internet. In Jones Creek we have players with levels 2.5 to 4.0. Last spring we had six Jones Creek ladies in the finals of the 3.5 teams competing for a berth in the state championships. Whether you are a beginner or a more advanced player, this program has a spot for you. There is no better way to have fun, make friends and compete than USTA League Tennis.

If you or you knew someone with a tennis rating of "B or C" and wonder how does the new ratings compute to the traditional terms of beginner, advanced beginner, intermediate, etc., or the frequently used letter a, b, c. aa, bb, aaa, etc.? Well the NTRP was designed to standardize the classification of player ability.

There is so much ambiguity associated with these systems that translation is difficult.

In various parts of the country for example "A" or "Advanced" is the top level of play, while in other places "AAA" is the best. In general terms, a D player would be a 2.5 and below; a C player would be a 2.6 - 3.5; a B player would be 3.6 - 4.5; and an A player would be 4.6 - 5.5; an open player would be 5.6 and above. Warning, most of the players in Jones Creek were recently advised, without prior notice, about a new local rule change soon be in effect in **January, 2006**. The new rule would limit the number of players on a team to no more than 30% of the players playing at a NTPR rating higher than the team's level.

Example: A team playing at the 3.5 NTPR level with 10 players on the roster must have seven players with a NTPR rating of 3.5 and no more than 3 players with a rating of 3.0 or less. The proposed rule would destroy at least one Jones Creek team and affect residents playing on ten other local teams! The CSRATA board of directors passed the rule, without polling the team captains, who are the blue-color managers of the association. Numerous complaints have been filed asking the board of directors to rescind their decision. It is believed that a ballot will soon be held with the CSRATA membership to ascertain the preference of the majority.

So far, players registering on one or more teams are down over 100 players from last year. Many players feel the CSRATA has lost sight of its mission to promote the development of the sport of tennis as a means of healthful recreation and physical fitness for all residents of the Central Savannah River Area.

It is a fact that 50% of the players will win or lose in a match and most would rather lose to a better player. CSRATA also shot themselves in the foot by restricting players from teams. The typical registration for a player to join a team is \$25; so if the enrollment drops by 100 that equates to \$2,500 in fees for a season. Most of the money is returned back to the community in the form of court rental fees paid by the association.

This issue is not as important to Jones Creek residents as Martinez and Evans are becoming a city, but I know more people being upset over the new tennis rule than the city concept.

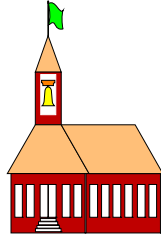

BIBLE STUDY OPPORTUNITIES

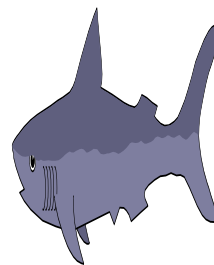

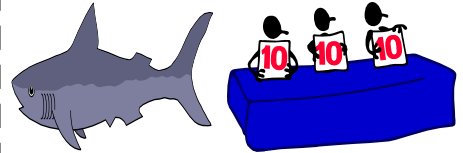

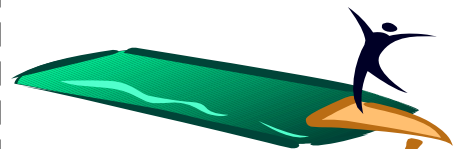
JONES CREEK SWIM TEAM REPORT

The Jones Creek Swim Team Board is beginning its annual fundraising efforts. This mainly consists of publishing the 2006 Annual Jones



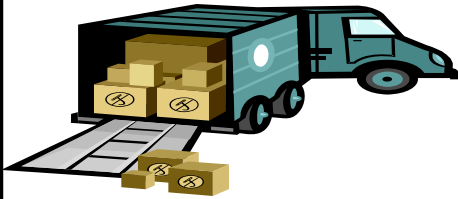
Creek Phone Book Directory to provide the revenues needed for coaches, salaries, equipment, awards, and for our membership in the CSRA swim program.

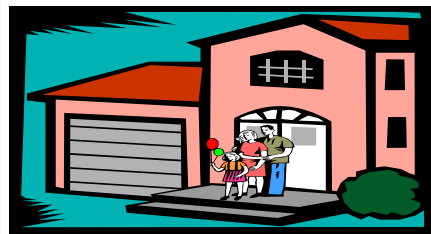

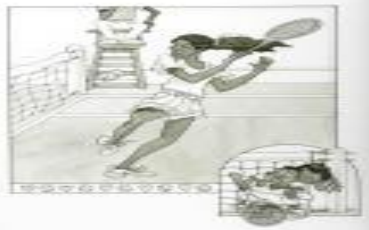
playing this great sport. A note of caution: All children's ages herein are approximate, for they grow up too quickly for me to keep up!!

I'll start with **Alexandra Metz**. She is ten and has been taking tennis lessons for close to three years. Alexandra attends Augusta Prep and plays in the Jones Creek Superstrings team in the 12 and under USTA Junior Tennis League. Alexandra always hits me with the hard questions, like "What are you going to be for Halloween, Mr. Xavier?" I am still working on that one. The entire Metz family plays tennis, including sister **Isabella**, who is 15 years old and plays the piano, sings, does volleyball and basketball at school, and is a charming young lady, to boot. Next is **J.P. Jeffcoat**. J.P., (real name- Jonathan) who is 11, also plays

REVISED JCOA DUES STRUCTURE FOR 2006

The Jones Creek Owners Association (JCOA) Special Committee on Dues Restructuring was formed a few months ago to assess the JCOA fiscal posture and determine the best overall strategy to keep Jones Creek looking like one of the premier communities in the area while also operating in the black. This special committee analyzed cost increases in recent years, evaluated pertinent facts, made some assumptions to help accurately size our budget, and determined options to keep our budget balanced.

The special committee noted that the JCOA operating costs have increased approximately 5 - 9% per year and landscaping and maintenance currently account for approximately 82% of the general fund budget. We do expect a significant increase in this cost for 2008, after our current 3-year landscaping contract expires. JCOA basically operates on a fixed income stream from JCOA dues. Our current dues of \$150 per year have not increased since 2001. For many years prior to 2001, the dues were only \$120 per year.

Although it is never pleasant to announce a cost increase, given our projected budget and costs, we recommended increasing JCOA dues for 2006 by \$100. This will keep us healthy until the 2008 landscaping contract is approved. The JCOA Board must then reevaluate the overall budget for 2008 and adjust as necessary. My thanks to the Committee for its hard work.

GMP/CELL TOWER

The Columbia County Growth Management Plan (GMP) Steering Committee has completed its work and the final version has been sent for the final approval process. The last approval will take place in **February 2006**.

The Fury's Ferry-Evans-to-Locks intersection was upgraded from a Tier 3 to a Tier 2, which will allow up to 100 acres of commercial with a square foot development of up to 1.2 million square feet (comparable to Fury's Ferry-Baston intersection). Unfortunately, our future is destined to probably have shopping centers on all four corners. Mixed use is a must. Therefore, it is important that residents ensure that the remaining 38 acres be professional or high-density housing. The only silver lining regarding the Tier 2 designation is that money has been allocated for a nodal architectural overlay to enforce certain standards for what the buildings, design and landscaping looks like.

On another note, Powertel will more than likely get approval for a 150-ft high cell tower behind the Martinez Bible Church property on Fury's Ferry Road. This cell tower will be visible to Jones Creek residents. The FCC regulations are such that it is almost impossible to deny the request. If you are concerned, contact the Board of Commissioners and let it be known just in case there is a recourse for stopping the tower location for being too close to Jones Creek.

In 1950, Columbia County's population was 9,525. 54 years later the population has grown to more than 100,000 people. Once a rural neighbor to Augusta, GA, Columbia County has become a bedroom community with serious discussions about incorporating Evans-Martinez into a city.

Rapid growth, which started in the 1980s and is continuing today, is being fueled by several factors:

- ◇ A growing and diversified job market inclusive of public sector (SRS, Fort Gordon), and private sector (Plant Vogtle, medical community) cornerstones.
- ◇ A school system that is superior to those of surrounding communities and better than average in the United States.
- ◇ Affordable land that is plentiful, although the affordable land is rapidly moving towards Appling.
- ◇ Open spaces that lend an air of the countryside; due to intelligent land management practices.
- ◇ A highly skilled work force, where household incomes rank third out of more than 100 counties in Georgia.
- ◇ A conservative county government.

We are indeed fortunate, as well as blessed to live here.
